

This Privacy Policy governs the manner in which Rogerup collects, uses, maintains and discloses information collected from users (each, a "User") of the websites: rogerup.com, plassion.com, newcave.com, and the Android and iOS Apps: Simple Games, Simple, Red Refill, Best Lap, Momiga, Pachinko 2, Pachinko 3. This privacy policy applies to the Apps, Sites and all products and services offered by Rogerup.

If you choose to use our Services, then you agree to the collection and use of information in relation to this policy. The Personal Information that we collect is used for providing and improving the Services.

Personal identification information

We may collect personal identification information from Users in a variety of ways, including, but not limited to, when Users use our Apps, when Users visit our site, register on the site, and in connection with other activities, services, features or resources we make available on our Apps and Sites. Users may be asked for, as appropriate, name or nick. Users may, however, visit our Site anonymously. We will collect personal identification information from Users only if they voluntarily submit such information to us. Users can always refuse to supply personally identification information, except that it may prevent them from engaging in certain activities.

Non-personal identification information

We may collect non-personal identification information about Users whenever they interact with our Apps or Sites. Non-personal identification information may include the browser name, the type of computer or device, technical information about Users means of connection to our Site, such as the operating system and the Internet service providers utilized, the IP Address, the country and city where the user are accessing from, and other similar information.

Web browser cookies

Our Sites may use "cookies" to enhance User experience. User's web browser places cookies on their hard drive for record-keeping purposes and sometimes to track information about them. User may choose to set their web browser to refuse cookies, or to alert you when cookies are being sent. If they do so, note that some parts of the Site may not function properly.

How we use collected information

Rogerup may collect and use Users personal information for the following purposes:

- * To run and operate our Apps and Sites

We may need your information to display content correctly.

- * To improve customer service

Information provided helps in responding the customer service requests, support needs more efficiently and turn the general experience more attractive.

- * To personalize user experience

We may use information in the aggregate to understand how our Users as a group use the services and resources provided on our Apps and Sites.

- * To improve our Apps and Sites

We may use feedback you provide to improve our products and services.

- * To process payments

We may use the information Users provide about themselves when placing an order only to provide service to that order. We do not share this information with outside parties except to the extent necessary to provide the service.

- * To manage product reviews and ratings

We may use third party service providers to help us manage product reviews and ratings left by Users.

How we protect your information

We adopt appropriate data collection, storage and processing practices and security measures to protect against unauthorized access, alteration, disclosure or destruction of your personal information, username, password, transaction information and data stored on our Apps and Sites. But remember that no method of transmission over the internet, or method of electronic storage is 100% secure and reliable, and absolute security cannot be guaranteed.

Sharing your personal information

We do not sell, trade, or rent Users personal identification information to others. We may share generic aggregated demographic information not linked to any personal identification information regarding visitors and users with our business partners, trusted affiliates and advertisers for the purposes outlined above.

Third part services and websites

Users will find advertising or other content on our Apps and Sites that link to the sites and services of our partners, suppliers, advertisers, sponsors, licensors and other third parties. We do not control the content or links that appear on these ads or sites and are not responsible for the practices employed by third party services linked to or from our Site.
